ORDER:

In the G.Os., first & second read above, Government have issued guidelines for identification of B.C. Voters in order to follow the rule 9 of Andhra Pradesh Municipalities (Reservation of seats in Municipal Councils and Nagara Panchayats) Rules, 1995 and to follow the amended Rule 10 of Andhra Pradesh Municipal Corporation (Reservation of Seats) Rules, 1995 respectively.

2. Government have conducted a review meeting on 27.01.2012 on the preparatory work of the 4th Ordinary Elections to Municipalities and Municipal Corporations to be conducted after final publication of Census 2011 by the Registrar General of Census, Government of India, in pursuant to the additional Counter Affidavit filed before the Hon'ble High Court in W.P.No.25998/2010 on 24.01.2012. In the said meeting among other issues the issue of identification of B.C. Voters in all the Urban Local Bodies in the State has been discussed and it has been decided to conduct the survey of B.C. Voters in all the Urban Local Bodies with effect from 06.02.2012.

3. Accordingly, Government hereby order the following schedule for identification of B.C. Voters as per latest Voter List Published, following the guidelines issued in the G.O. 1st read above:
