### ORDER

The Commissioner and Director of Municipal Administration, A.P., Hyderabad in the reference 1st read above has submitted proposals for inclusion of surrounding fifteen (15) Gram Panchayats i.e., 1) Nallapadu (remaining part), Koritepadu (remaining Pedakakani part), 3) Ankireddypalem(remaining part), 5) Venigandla (Full), 6) Agathavarappadu (remaining part), 7) Pothur (Full), 8) Chowdavaram (Full), 9) Etukuru (remaining part), 10) Takkelapadu (remaining), 11) Budampadu (Full), Pedapalakaluru(Full), 13) Guntur North (Reddy Palem) (Remaining part) 14) Adavitakkellapadu (remaining village) and 15) Gorantla (Full) and requested the Government for taking necessary action and issue orders in the matter.

2. The District Collector, Guntur in the reference 2<sup>nd</sup> read above has stated that out of (15) Gram Panchayats mentioned above, Koritepadu and Guntur (village) do not have any Panchayats. The resolutions of the remaining Gram Panchayats are obtained and all the above Gram Panchayats have agreed for inclusion of their Gram Panchayats in to the limits of Guntur Municipal Corporation, Guntur, except the Gram Panchayats of Pedakakani, Venigandla, Agathavarappadu and Takkellapadu. The Reddipalem Gram Panchayat has also passed a resolution for inclusion in Municipal Corporation, Guntur. He has, therefore, recommended to include ten (10) Gram Panchayats viz., 1.Nallapadu (full), 2.Pedapalakaluru(Full), 3. Ankireddipalem (Remaining part), 4. Adavitakkellapadu (full), 5. Gorantla (Full), 6. Pothuru (full), 7. Chowdavaram (Full), 8. Etukuru (Remaining part), 9. Budampadu (Remaining part) and 10. Reddypalem (full) into the limits of Guntur Municipal Corporation, Guntur.

- 3. The Government have examined the report of the District Collector, Guntur and decided to accept the proposal for inclusion of ten (10) Gram Panchayats viz., 1.Nallapadu (full), 2.Pedapalakaluru (Full), 3. Ankireddipalem (Remaining part), 4. Adavitakkellapadu (full), 5. Gorantla (Full), 6. Pothuru (full), 7. Chowdavaram (Full), 8. Etukuru (Remaining part), 9. Budampadu (Remaining part) and 10. Reddypalem (full) into the limits of Guntur Municipal Corporation, Guntur.
- 4. Accordingly, under sub-section (2) of Section 3 of the Andhra Pradesh Municipal Corporations Act, 1994, a Show Cause Notice has been issued in the reference 3<sup>rd</sup> read above to the Special Officer/ Commissioner, Guntur Municipal Corporation to communicate its views / objections / suggestions, if any on inclusion of above (10) Gram Panchayats into the limits of Guntur Municipal Corporation, Guntur within a period of 10 days from the date of receipt of this notice the Commissioner, Guntur Municipal Corporation has also been directed to publish the said proposal in news paper and give wide publicity and affix a copy of the notice on the Notice Board of the Municipal Corporation and other important public places for ascertaining the view of the Public and to place it before the Municipal Corporation and furnish report to the Government along with the Municipal Corporation resolution duly following the procedure for taking further action in the matter.
- The Commissioner, Guntur Municipal Corporation in the reference 5<sup>th</sup> read above has informed that the Municipal Corporation Council in their Resolution No. 1067, dated: 19.06.2012 have accepted the proposal for inclusion of viz., surrounding (10)Gram **Panchayats** 1.Nallapadu 2.Pedapalakaluru(Full), 3. Ankireddipalem (Remaining part), Adavitakkellapadu (full), 5. Gorantla (Full), 6. Pothuru (full), 7. Chowdavaram (Full), 8. Etukuru (Remaining part), 9. Budampadu (Remaining part) and 10. Reddypalem (full) into the limits of Guntur Municipal Corporation and requested the Government for taking further action in the matter.
- **6.** In the reference 6<sup>th</sup> read above, the Government in Panchayat Raj and Rural Development Department have de-notified the above said ten (10) Gram Panchayats of Guntur District for inclusion into Guntur Municipal Corporation in Guntur District.
- 7. The Government, after careful examination of the matter decided to include (10) Gram Panchayats viz., 1.Nallapadu (full), 2.Pedapalakaluru(Full), 3. Ankireddipalem (Remaining part), 4. Adavitakkellapadu (Full), 5. Gorantla (Full), 6. Pothuru (Full), 7. Chowdavaram (Full), 8. Etukuru (Remaining part), 9. Budampadu (Remaining part) and 10. Reddypalem (Full) into the limits of Guntur Municipal Corporation.
- **8.** The following notification will be published in an Extra-Ordinary Issue of the Andhra Pradesh Gazette **dated:13.07.2012.**
- **9.** The Commissioner, Printing, Stationary and Stores Purchase, Hyderabad is requested to publish the above notification and furnish 50 copies of the Andhra Pradesh Gazette to the Government immediately.

#### **NOTIFICATION**

- 6. Pothuru (full),
- 7. Chowdavaram (Full),
- 8. Etukuru (Remaining part), with revenue Survey Numbers 236 to 240, 242 to 251, 257 to 284, 297 to 321, 330 to 441.
- 9. Budampadu (Remaining part), with Survey Numbers 1 to 396.
- 10. Reddypalem (full).
